CONDITIONS

2 & 3 Year Old Stakes to be raced under rules of Ohio Fair Fund Law and conditions of North Central Colt Stake Circuit.

Overnight events - USTA Rules to govern. Entrance fee \$35.

All races to be one mile dash.

Entrance fee must be paid on every entry made whether Stake or Overnight.

The Fairboard reserves the right to change the program, declare off any event, or reject any entry. The Society assumes no liability in case of accident on the racetrack or on the grounds.

Right reserved to postpone races, change order of program or declare races off for any reason. If not enough nominations are received, the Fair reserves the right to call off the race and to refund the money.

Money divided: 45 - 25 - 15 - 10 - 5 percent. No more monies will be paid than there are starters. First place checks will be held pending lab test results.

A fee of \$30 will be charged on all returned checks.

Passes issued by the North Central Ohio Colt Circuit will be honored at gate. ALL OTHERS WILL PAY FULL GATE ADMISSION.

All horses enter Fairgrounds through Gate No. 4.

Lasix will be the responsibility of the trainer.
